### **RATES AND DATES**

The five-week Dance Summer Session at the Baltimore School for the Arts is run solely on the tuition of the attending students. It is not funded by Baltimore City Schools or the Baltimore School for the Arts Foundation. Classes will be held Monday through Friday from 9am – 3:30pm, June 19<sup>th</sup> – July 21<sup>st</sup> and are only open to currently enrolled students, our incoming freshman class, alumni and students in the TWIGS levels A1, A2, A3 and A4. Although it is recommended that the dancers attend the full session, applicants may attend the number of weeks that accommodates their summer schedule.

### **HOW TO APPLY**

Complete and mail in the attached release and registration forms along with the \$50.00, separate, non-refundable registration fee no later than May 26, 2017. Only completed application forms accompanied by a \$50 registration fee will reserve your dancers place in the program.

- We are offering a discounted rate to families who register and pay in full for the entire five weeks by **Friday, April 28, 2017**!
- If you do not wish to pay in full, weekly and bi-weekly payment plans are available if you register before *Friday*, *May* 19, 2017.
- After *May 19, 2017* payment in full will be required at the time of registration.
- The balance of the total cost of tuition is due no later than **Friday**, **June 2**, **2017**.
- If a dancer is unable to attend the summer session after payments have been made, 50% of the tuition costs may be refunded as long as a written statement has been presented to the Dance Department Head **prior to start date of the session.**
- After the start date of the summer session, *no refunds are available*.
  - Online and email registration is not available.
