## RATES AND DATES

The five-week Dance Summer Session at the Baltimore School for the Arts is run solely on the tuition of the attending students. It is not funded by Baltimore City Schools or the Baltimore School for the Arts Foundation. Classes will be held Monday through Friday from 9am – 3:30pm, June 19<sup>th</sup> – July 21<sup>st</sup> and are only open to currently enrolled students, our incoming freshman class, alumni and students in the TWIGS levels A1, A2, A3 and A4. Although it is recommended that the dancers attend the full session, applicants may attend the number of weeks that accommodates their summer schedule.

## HOW TO APPLY

Complete and mail in the attached release and registration forms along with the \$50.00, separate, non-refundable registration fee no later than May 26, 2017. Only completed application forms accompanied by a \$50 registration fee will reserve your dancers place in the program.

- We are offering a discounted rate to families who register and pay in full for the entire five weeks by **Friday, April 28, 2017!**

- If you do not wish to pay in full, weekly and bi-weekly payment plans are available if you register before **Friday, May 19, 2017.**

- After **May 19, 2017** payment in full will be required at the time of registration.

- The balance of the total cost of tuition is due no later than **Friday, June 2, 2017.**

- If a dancer is unable to attend the summer session after payments have been made, 50% of the tuition costs may be refunded as long as a written statement has been presented to the Dance Department Head **prior to start date of the session.**

- After the start date of the summer session, **no refunds are available.**

- Online and email registration is not available.

**BALTIMORE SCHOOL FOR THE ARTS SUMMER INTENSIVE RELEASE FORM**

*In consideration for permitting my child to participate in any of the Baltimore School for the Arts Summer Intensive Programs (the "Program") I hereby agree: (a) To release and discharge Baltimore School for the Arts (the "School") from any liability or responsibility for any personal or bodily injury (including death), and for any damage to or loss of property, however caused, that my child or I suffer as a result of or in connection with my child's participation in the Program, other than for damage or loss resulting directly from the negligent acts or willful misconduct of the School; and (b) Not to raise any claim or institute any legal action proceeding, on my behalf or on behalf of my child, against the School for any cause of action that may result from or arise out of or in connection with my child's participation in the Program, for any injury (including death) to my child, other than for damage or loss resulting directly from the negligent acts or willful misconduct of the School; and (c) To indemnify the School and hold it safe and harmless from and against any claim or cause of action asserted by my child, or on behalf of my child, against the School, for loss of, or damage or injury (including death) to, his or her person or property, resulting from, arising out of, or occurring in connection with my child's participation in the Program, other than for damage or loss resulting directly from the negligent acts or willful misconduct of the School. All references to the School in this form shall include, and all provisions of this form shall insure to the benefit of, the School's trustees, officers, employees, agents, servants, and representatives. I have no knowledge of any physical impairment that would affect my child's ability to participate in the Program. I authorize the School to request medical treatment as necessary to insure the well-being of my child while attending the Program. I agree that my child will comply with all applicable rules, policies, and procedures of the School. This release shall be governed by and construed in accordance with the laws of the State of Maryland applicable to contracts entered into and intended to be performed solely within the state of Maryland. I shall submit to the jurisdiction of the federal and state courts located in Baltimore City, Maryland, for the resolution of disputes arising hereunder or relating hereto, regardless of the place of execution hereof. By signing below, I hereby grant the School the right to take photographs of my child in connection with the Camp. I authorize the School, its assigns and transferees to copyright, use and publish the same in print and/or electronically. I agree that the School may use such photographs with or without my child's name and for any lawful purpose, including such purposes as publicity, illustration, advertising, and Web content.*
